Change to Onboarding Requirements – Introduction of Industry Member CAT Reporter Limited Testing

- > Original Requirement: To gain entitlement to CAT Systems, all Industry Members required to sign a CAT Reporter Agreement.
- > New Requirement: Industry Member CAT Reporters that have not yet signed the CAT Reporter Agreement may be entitled to the IM Test Environment if they sign an *Industry Member Limited Testing*Acknowledgement Form. Limitations:
 - IM CAT Reporters using this method will be prohibited from submitting production data. Any data must either be fabricated test data or obfuscated.
 - IM CAT Reporters **MUST** complete their Production Readiness Testing with Production data (required by April 6 for 2a and May 4 for 2b).

Functionality in Industry Test as of December 16, 2019 (continued)

- Machine-to-Machine Testing
 - File Acknowledgement, File Integrity and Data Integrity (syntax/semantics) validations are available
 - Industry Members and CAT Reporting Agents must comply with the published technical specifications
- CAT Reporter Portal Release of:
 - Basic File Reporting Statistics
 - Manual File Upload
 - ✓ User Role of CAT Administrator or CAT User is required
 - ✓ Files MUST meet the Technical Specification requirements (naming, syntax, compression requirements, etc.)
 - ✓ Files must be <=1GB in size AND total record count may not exceed 100,000
 - ✓ Meta and Data files are BOTH required Data files must be submitted prior or at the same time as Meta Files
 - ✓ No limit to the number of files submitted using File Upload; however a limit of 10 files for a single submit, with max limit of 5GB
 - ✓ File and Data Integrity Feedback files submitted using Manual File Upload available for download via the Reporter Portal

FINRA CAT Observations on Day 1 Submissions

- On Day 1 of Industry Test, FINRA CAT observed file and ingestion rejections due to the following:
 - Missing Reporting Relationships Files will be rejected if relationships are not yet established
 - Invalid file name constructs. Examples include:
 - SubmitterID is incorrect
 - fileSequence should be 6 digits
 - file type should be OrderEvents
 - Data file name in the meta file must be the full file name including compression and extension
 - Case sensitivity in JSON Labels in meta data files are case sensitive

Known FINRA CAT Issues

General Notification:

- > FINRA CAT Network team is assisting some firms with additional details related to their use of IP proxy based access.
 - **Resolution**: FINRA CAT is updating the Connectivity Supplement with additional firewall and URL information in support of Industry member's use of IP Proxy based access. These details are also provided in the Appendix of this presentation.

Resolved:

- Firms were unable to upload files when they are east of the GMT time zone.
 - **Resolution**: FINRA CAT released a patch on December 16, 2019, and the issue is now resolved.

In Development/Test:

- MEOT Records with <BLANK> Firm Designated ID rejecting as invalid.
- Metadata file rejecting as "Not Readable" when the last delimiter is missing in CSV.
- > Allowable values included in latest Technical Specification 2.2.1 r2 need to be updated in Industry Test.
- Acknowledgement Feedback Files only include base filename. Per specification, acknowledgements should include the full filename.
- Patch Release is targeted for Thursday, December 19.

Under Review:

- > FINRA CAT accepting events as opposed to rejecting in the following scenarios:
 - Equity events where the representative indicator or the fulfillment link type value is 'O'.
 - Values populated in 'Reserved for Future Use' fields.
 - Future dates in some fields.
 - Route Event with Destination Type of 'E' or 'F' and Sender IMID of <BLANK>.

Other Release Notes & Reminders

- Private line connectivity to CAT needs to be established and a connectivity ping test completed as soon as possible. Firms and reporting agents should note that the ping test <u>may be completed prior</u> to signing the CAT Reporter Agreement and obtaining CAT Reporter Portal entitlements.
- If private line connectivity is NOT yet established, Industry Members may still begin testing using the CAT Reporter Portal via the Manual File Upload. Requirements for CAT Reporter Portal:
 - ✓ Industry Members must have a signed CAT Reporter Agreement or an Industry Member Limited Testing Acknowledgement Form
 - ✓ A CAT Reporter Portal CAT Admin or User account must be established
 - ✓ The SRG requires multi-factor authentication (MFA) to establish a secure, encrypted session before accessing the CAT Reporter Portal
 - ✓ No limit in choice of Internet Service Providers and no specialized client software is required to be installed other than a modern web browser (HTML5 Compatible browsers including: Chrome, Firefox and Safari)

Other Release Notes & Reminders

- ➤ Industry Members must certify with a day of Production data by April 6, 2020 for 2a and May 4, 2020 for 2b.
- > Firms may use limited historical data to submit to the Industry Test Environment (from November 15, 2019 forward).
- > During the Industry Test period, FINRA CAT will continue to monitor:
 - Network and Connectivity Performance
 - Rejections and Errors




