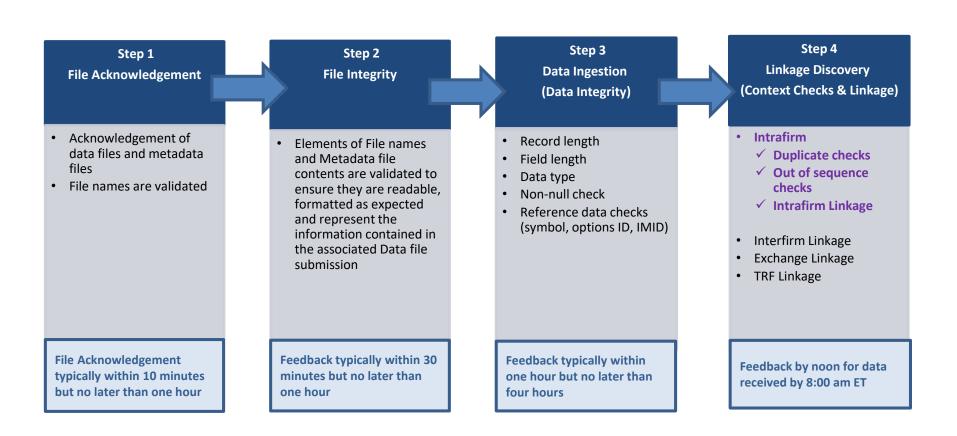

General Processing Overview

General Overview - CAT Data Processing

- The CAT Plan Processor ingests and validates data to ensure it is submitted in accordance with the CAT Reporting Technical Specifications for Industry Members
- The CAT Plan Processor provides specific feedback to CAT Reporters to assist them with Compliance obligations
- The CAT Plan Processor provides tools and resources to assist firms in correcting erroneous data

CAT Processing



Intrafirm Processing Steps

| Seq | Linkage Discovery Step | Feedback |
|-----|---------------------------------------|---------------------------------------------------------------------------------------------------------|
| 1 | Full Duplicate Checks | When duplicates are found, one record is kept and all others are rejected. |
| 2 | Key Duplicate Checks | When an Event key or a Firm ROE ID is duplicated, all events having the same key are rejected. |
| 3 | Intrafirm Linkage and Out of Sequence | Events within a firm that do not link AND Events within a firm that are linked but are out of sequence. |

Feedback Format & Availability

Feedback delivered via SFTP

- > The feedback format will match the format of the original submission
- > Feedback files will be accessible in the Submitter's feedback directories
- Feedback for data submitted by a CAT Reporting Agent on behalf of a CAT Reporter will be accessible under the CAT Reporter's feedback directories if the CAT Reporter has an SFTP account
- > Feedback will remain available for 10 calendar days

Feedback available on the Reporter Portal

- Machine formatted feedback files for all submission types will be accessible for download by the CAT Reporter and Submitter
- Machine formatted feedback files will remain available for 10 days

Intrafirm Error Codes

| Error Code | Туре | Explanation |
|------------------------------------------------------|--------------------|----------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------|
| 397 | Warning | Event reported beyond the linkage processing window; such events are considered late and will participate in the Error Rate in the Late category. |
| 398 | Warning | When Intrafirm linkage is not successful, secondary events having an Event Key Date which is prior to CAT go-live will be assigned this Warning. |
| 399 | Warning | When an event is fully duplicated, one version is accepted and all other versions are rejected. |
| 3002, 3003 | Rejection | Duplicated Firm ROE ID. Firm ROE ID must be unique for the Event Date and CAT Reporter IMID. |
| 3004, 3007, 3010, 3011, 3012, 3015, 3016, 3017 | Rejection | Duplicated Event Key. Event Key must be unique for the Key Date, Key ID, CAT Reporter IMID, Event Date and Symbol. All events having a duplicated key are rejected. |
| 3008, 3009 | | Retired |
| 3501 | Unlinked Error | Secondary event is unlinked to the Primary event. "Parent Not Found". Errors occur when Primary event was rejected or not reported, or when the Event Key is incorrect. |
| 3502, 3503, 3504 | Unlinked Error | Side details or Aggregated Orders references one or more orders that are not found. Errors occur when orders that is referenced was rejected or not reported, or when the Order Key that is referenced is incorrect. |
| 3601 | Out of Sequence | Linkage occurred between primary and secondary event, but the timestamps were out of sequence. |
| 3602 | Out of Sequence | Supplement event has an event timestamp that is different from the event that it is supplementing. CAT Reporting requires these times to be equal. |

Intrafirm Linkage

> Included:

- Secondary events where a linkage to a primary event is required including Routes, Cancels, Child Orders, Internal Routes, Modifications, Adjustments and Supplements
- Fulfillment and Trade Events where orders are populated in the side details
- Representative orders / Aggregations where orders are populated in the Aggregated Orders field
- ➤ Unlinked Events are delivered when an Intrafirm Linkage was not made, excluding:
 - Full and Event Key Duplicates
 - Events originated prior to CAT go-live
 - Events reported beyond the processing window
 - Representative order not required to link

Correcting Intrafirm Duplicate and Unlinked Errors

Error Feedback

- Error feedback returned to CAT Reporters will include the associated Error Code(s) and the Error Record Identifier errorROEID
- Assigned an initial repair status of Unrepaired ('U')

Reporting Corrections

- Distinguished using the Action Type Code
 - 'RPR' must include errorROEID of the CAT identified error being corrected
 - 'COR' must include firmROEID of the CAT identified error or CAT Reporter reporting error being corrected
 - 'DEL' may include the errorROEID or the firmROEID
- The use of a 'DEL' event can be used to remove an erroneous event which resulted in an error







