Observations

- > Firms are populating '0' in the *minQty* and *cancelQty* fields.
- > timeInForce is expected to have one choice value.
- > timeInForce of DAY requires the expiration date to be equal to Event Date or Event Date plus one Trading Day.
- > Firm initiated same day corrections must be reported after receiving file ingestion feedback for the file in which the original record was submitted.

- > The ability to delete files from the SFTP errors and feedback directories is now available in the Production and Test Environments.
- ➤ Effective June 1, 2020, all CAT users enrolled in Duo multi-factor authentication (MFA) must authenticate via Duo Push or USB-enabled security key to access CAT. One-time password authentication will no longer be permitted. An e-mail notification was sent to impacted users on May 12, 2020.



- Upon verification of the Production Readiness Testing and all other Onboarding Steps by FINRA CAT, CAT Reporters will be granted access to the CAT Production Environment, and a notification confirming access will be sent.
