 - Correct population of IMIDs

Exchange Linkage Update

- Exchange unmatched rates overall are approximately:
 - 27% for equities exchanges
 - 49% for options exchanges
- Areas to focus on:
 - session: ensure session meets the exchange requirements and does not include any characters that were not sent to the exchange
 - senderIMID: may be different from the CATReporterIMID- verify with the exchange what the SRO-assigned identifier is
 - routedOrderID: the inclusion or deletion of special characters such as spaces, underscores or slashes in order to match the routedOrderID captured by the exchange

TRF Linkage Update

- TRF unmatched rates overall are approximately 33%
- Areas to focus on:
 - tapeTradeID vs. tradeID:
 - tapeTradeID is the Compliance ID, Branch Sequence Number or FINRA Compliance Number
 - tradeID is the Unique ID assigned to this execution by the Industry Member
 - Linking to the correct side of the trade report
 - Reporting Side MPID must match the Reporting Side Compliance ID, Branch Sequence Number or FINRA Compliance Number and Contra Side MPID must match the Contra Side Compliance ID, Branch Sequence Number or FINRA Compliance Number. It is not permissible for the Reporting Side MPID to match the Contra Side Compliance ID, Branch Sequence Number or FINRA Compliance Number or vice versa.

 - New FAQs Q32 Q37 related to Customer and Account Information, including CAIS LTID reporting requirements
 - New FAQs U17-U22 related to allocation reporting

FAQ Updates

- ▶ 6 Updated FAQs published since the last Monthly CAT Implementation Update (September 17, 2020).
- ▶ No change in guidance— only language clarification:
 - Updated FAQ B12 regarding reporting of the equity leg of a complex order
 - Updated FAQ F3 regarding agency orders filled on an average price basis
 - FAQs B49, U2 and U16 regarding booking of shares/contracts
- FAQ B7 was retired and moved to Section I, Foreign Securities as New FAQ I9
 - No change in guidance only language clarification

Unique orderID Requirements

- As of September 28, 2020, the Phase 2d CAT Reporting Technical Specifications for Industry Members is being updated to remove the requirement for Industry Members to change and provide a new unique orderID on CAT Order Modification and Order Adjustment events.
- This update will be reflected in the next version of the CAT Reporting Technical Specifications for Industry Members which will be posted to www.catnmsplan.com on November 6, 2020.
- An email announcement was sent to all subscribers of the Consolidated Audit Trail (CAT) Email Subscription Service on September 28, 2020.

CAIS LTID Registration and Onboarding

- Although it was recommended that all organizations that need to access CAIS for the submission of LTID data complete the registration form no later than October 5, 2020, registration will remain open.
- Reporters that have no accounts with associated LTIDs to report at this time are still encouraged to complete the registration process in order to quickly and efficiently onboard in the future if and when necessary.
- CAIS LTID Production Certification opened on October 5, 2020 and remains open.
