Options Exchange Linkage Updates

Observations on Options Exchange Route Matching

- Sender IMID is now the largest source of forward errors. It is necessary for Industry Members to work directly with each exchange to ensure both the IM and the exchange are reporting the same IMID to CAT.
 - Note the IMID is any SRO-assigned identifier and is not necessarily the MPID.
- Sender IMID mismatches are occurring on routes to the Miami Option exchanges, since many IMID values include a trailing space. FINRA CAT strips the trailing spaces on the IM data but not on the participant side resulting in the unlinked errors. MIAX is working on a change to remove the trailing spaces from sender IMID codes on the CAT submissions. **This change was originally scheduled for November 13, 2020, but is currently being rescheduled.**
- Firms are getting named errors from NASDAQ option exchanges due to an internal system route happening at the exchange. The original routing party is being sent on the internal route event, so FINRA CAT is attempting linkage. **Update: This issue is scheduled to be resolved on November 30, 2020 in the Test Environment and December 7, 2020 in the Production Environment.**
- Option floor trades effected on the CBOE floor are resulting in named errors. CBOE and FINRA CAT are aware of the issue and are working toward a resolution.
- Option floor trades effected on the ARCAOP and AMEROP floors are resulting in named errors. NYSE Options and FINRA CAT are aware of the issue and are working toward a resolution.

- The October 2020 Industry Member Compliance Report Cards were published on November 16, 2020. Linkage statistics under compliance on October 26, 2020 will be added to the November Report Card as it will be the first full month of compliance.
- Updated Industry Members Schemas for Phase 2a/2b and Phase 2c were published on November 12, 2020.

Reminders

- The Weekly Industry Testing Checkpoint Call scheduled for November 24, 2020 is cancelled.
- There are two versions of the Options Start of Day and End of Day symbol files, one with the Test Option Series flag identifying options test symbols and one without the test flag. Existing versions of the files without the test flag will continue to be available until December 14, 2020, when they will be retired. Firms that use these files should plan to transition to the new versions prior to that time.
- Workstations running end-of-life operating systems will be blocked from accessing CAT applications effective Monday, December 7, 2020. After that date, users will not be able to access CAT applications with the affected system until it is upgraded to a supported version of the operating system. All impacted users have been sent notification emails.
