Observations on Options Exchange Route Matching

Exchange Family	Description	Error Types	Status
NASDAQ	Firms are getting named errors from NASDAQ option exchanges due to an internal system route happening at the exchange. The original routing party is being sent on the internal route event, so FINRA CAT is attempting linkage. NASDAQ and FINRA CAT are working to resolve this issue.
