### **CAIS** Reporting Overview

- The reporting of Customer Identifying Information and Customer Account Information consists of two phases:
  - LTID Account Phase: April 26, 2021 through July 10, 2022
    - Subject to the phasing requirements set forth in the plan
  - Full CAIS Phase: Starting on July 11, 2022
- ➤ In order to facilitate testing of Full CAIS data, the Full CAIS schema will be deployed into the Test, Production Mirror ("Prod-Mirror") and Production Environments in phases:
  - Industry Test Release
  - Transition Period
  - Full CAIS Go-Live

### CAIS Reporting Overview- Continued

- ➤ After the Full CAIS schema deployment in each environment:
  - CAT Reporters may submit data in either the LTID Account Phase (schema version 1.0.0) or Full CAIS Phase (schema version 2.0.0) until July 10, 2022
  - Industry Members still have an obligation to report FDIDs having LTID associations to the Production Environment until July 10, 2022
  - The Production Go-Live date for all Industry Members for Full CAIS reporting requirements is July 11, 2022
    - On and after July 11, 2022, CAT Reporters may only submit data to all environments in the Full CAIS Phase format (schema version 2.0.0)

### Test Environment Plan Overview

- In order to facilitate testing of Full CAIS (Phase 2e) data, effective January 31, 2022, the Test Environment will accept submissions in both the LTID Account Phase schema (version 1.0.0) and the Full CAIS Phase schema (version 2.0.0 or higher) until July 10, 2022.
- ➤ Code deployment to the Test Environment will begin at approximately 8 am ET on January 30, 2022.
- ➤ Users currently properly entitled to the Test Environment for the LTID Account Phase will retain their entitlement.
- Reporting relationships currently established in the Test Environment for the LTID Account Phase will remain.

### Transition Period (April 24-July 10, 2022)

- > To facilitate the transition from LTID Account Phase (schema version 1.0.0) to Full CAIS Phase (schema version 2.0.0 or higher), CAT Reporters may begin reporting Full CAIS Phase submissions to the Production and Prod-Mirror Environments on April 24, 2022.
- Code deployment to the Production and Prod-Mirror Environments will begin at approximately 8 am ET on April 24, 2022.
  - Prior to code deployment, all submissions to the Production and Prod-Mirror Environments must be in schema version 1.0.0
- During the Transition Period between April 24, 2022 and July 10, 2022:
  - The Test Environment will accept submissions in both the LTID Account Phase schema (version 1.0.0) and the Full CAIS Phase schema (version 2.0.0 or higher).
  - The Production and Prod-Mirror Environments will accept submissions in both the LTID Account Phase schema (version 1.0.0) and the Full CAIS Phase schema (version 2.0.0 or higher), if the Industry Member has been certified for Full CAIS Production reporting.
- > To ensure that Industry Members can submit the full suite of required data to the Production Environment by the Go-Live date of July 11, 2022, CAT Reporters are encouraged, but not required, to submit data to the Production Environment in Full CAIS format during the Transition Period.

### Transition Period (April 24–July 10, 2022) – Other Notes

- ➤ Once a Firm Designated Identifier (FDID) record has been accepted into CAT CAIS in a Full CAIS Phase (v2.0.0) submission, attempting to submit the FDID again in an LTID Account Phase (v1.0.0) submission will result in a rejection of the record.
  - ➤ If the FDID has not been accepted in a Full CAIS Phase (v2.0.0) submission, FDID rejections received against a Full CAIS Phase submission may be repaired by submitting the FDID again in an LTID Account Phase (v1.0.0) submission.
- ➤ All active FDID records reported in the LTID Account Phase (v1.0.0) submission must be accepted in a Full CAIS Phase (v2.0.0) submission on or before July 11, 2022.
- Please note that unlike in the LTID Account Phase, CAT Reporters must submit the entire record rather than just the delta.

### **FDID Version Reporting**

- > To support the transition from LTID to Full CAIS reporting, an FDID Version Report containing the list of active FDIDs received in an LTID Account Phase submission and not yet accepted in a Full CAIS Phase submission in the Production Environment, will be made available within the CAT CAIS Reporter Portal UI in June of 2022.
- > The FDID Version Report will contain the list of FDIDs for the Industry Member that have been accepted as an LTID Account Phase submission, have not been ended in CAIS, and have not been accepted as a Full CAIS Phase submission in the Production Environment.
- > These FDIDs are required to be accepted in the Production Environment in the Full CAIS Phase schema, or ended in CAIS, on or before July 11, 2022.

### Full CAIS Go-Live

- ➤ The Full CAIS (Phase 2e) Production Go-Live Date for all Industry Members is July 11, 2022.
- Starting at approximately 8 am ET on July 10, 2022, all submissions to all Environments must be in the Full CAIS Phase format, no matter when the Industry Member received the data.
- > Additionally, after code deployment on July 10, 2022:
  - All data and TID files must follow schema version 2.0.0 or higher. Any files that are received after code deployment on July 10, 2022 with a prior schema version will reject.
  - All data, including repairs and corrections for rejections that originated prior to code deployment on July 10, 2022 must be reported in the Full CAIS Phase format.

### Full CAIS Cutover Deployment

FINRA CAT will communicate via email and system announcements when the code deployment is complete.

#### **≻**Recommendation:

- Due to code deployment in all environments on July 10, 2022
  - CAT Reporters should not submit any files in the LTID Account Phase schema (v1.0.0) after 11:59 pm ET on July 9, 2022.
  - CAT Reporters should not submit any files to any environment on July 10, 2022
- Submissions for the July 11, 2022 CAT Processing Date should not begin until notification that the Full CAIS Phase deployment is completed.

### Feedback and Repairs

- > After Full CAIS Phase code deployment to each environment:
  - LTID Phase (v1.0.0) submissions
    - Will be validated against the LTID Phase file and record schema.
    - Feedback for LTID Phase submissions will be provided in in the CAIS Data Feedback file in the Full CAIS Phase (v2.0.0) format omitting attributes that are not applicable for LTID Phase submission e.g., receivedNaturalPersonRecordCount, successfulNaturalPersonRecordCount, receivedLegalEntityRecordCount, successfulLegalEntityRecordCount.
    - No Identifiers Feedback nor Submission Inconsistencies Feedback files will be generated for the LTID Phase Submissions.
  - Full CAIS (v2.0.0) submissions
    - Will be validated against the Full CAIS Phase file and record schema.
    - Feedback for Full CAIS Phase submissions will be provided in the CAIS Data Feedback, CAIS Identifiers Feedback, and CAIS Submission Inconsistencies Feedback files in the Full CAIS Phase (v2.0.0) format.
  - Any FDID record rejections must be repaired by the Repair Deadline.
- Any outstanding LTID Account Phase rejections as of July 10, 2022, must be repaired in the Full CAIS Phase format
  - Because CAIS data is PII and cannot be returned to the CAT Reporter, data is not included in the feedback file to assist with resubmission
  - For this reason, CAT Reporters are encouraged to transition away from version 1.0.0 to version 2.0.0 during the Transition Period (April 24, 2022 through July 10, 2022)

### Full CAIS Phase Schema Updates

- ➤ The transition from LTID Account Phase to Full CAIS Phase 2e includes modifications to the current CAIS Data submission file, as well as the introduction of the new TID file.
- A detailed list of schema changes between LTID Account Phase and Full CAIS Phase 2e, new record types and the TID file layout, is as follows below.



# **CAIS** Reporter Portal Functionality

- CAIS Reporter Portal will facilitate submission of either LTID Phase or Full CAIS Phase submissions during the transition period (April 24-July 10, 2022). The LTID Phase reporting functionality will be deprecated on July 11, 2022 no further LTID Phase reporting will be accepted once the Full CAIS Mandatory Reporting deadline has been reached.
- ➤ A toggle within the UI will allow users to flip between LTID Phase and Full CAIS Phase reporting.
- ➤ NOTE example screens in this deck are conceptual mock-ups and not yet finalized; as such, the final screens may change. An updated CAIS Reporter Portal user guide will be published with details on the finalized functionality.


# Example Screen - LTID Phase File Upload

- 'Full CAIS' toggled OFF
- Allows upload of LTID Phase files in the same manner as current CAIS Reporter Portal functionality
- Records must only have LTID Phase attributes




### Example Screen - Full CAIS Phase File Upload

- 'Full CAIS' toggled ON
- Allows upload of paired
   Full CAIS files Data File
   and Transformed
   Identifiers File within the
   UI
- Records must have Full CAIS attributes – including customer associations and data




# Example Screen - LTID Phase Manual Entry

- 'Full CAIS' toggled OFF
- Allows entry of FDID records following the LTID Phase version schema
- Very similar to current LTID
   Phase functionality only
   minor layout revisions



# Example Screen - Full CAIS Phase Manual Entry

- 'Full CAIS' toggled ON
- Allows entry of attributes following Full CAIS version schema
- Left-side hierarchy view will show customer associations as they're added to the submission
- Only one FDID submission at a time – plus all associated customers and LTIDs
- Includes in-browser mechanism for converting Input Identifier to Transformed Identifier
