# 2d Statistics & Observations

## As of November 17, 2021

---

- Total **1134** Unique Firms and **171** Unique Submitters in Industry Test
- Overall File Rejection Rate is **3.40%**
- Approximately **11.74%** of submissions are New 2d Events; **0.61%** of submissions are Multi-leg Events
- Most of the Unlinked Interfirm, Exchange and Trade are due to:
  - Not all firms reporting in Test Environment
  - Firms reporting test symbols that are matched with production data for Exchange and Trade Linkage
- Coordinated Industry Test
  - **362** unique IMIDs participated in the 9/10 Industry Test
  - **505** unique IMIDs participated in the 10/1 Industry Test
  - **561** unique IMIDs participated in the 10/15 Industry Test
  - **776** unique IMIDs participated in the 10/29 Industry Test
  - **1044** unique IMIDs participated in the 11/12 Industry Test
