CAT NMS Plan, Exemptive Relief and Interpretive Updates

Exemptive Request Letters

- On September 13, 2021, the Plan Participants submitted to the SEC a <u>request for temporary</u> <u>exemptive relief</u> from the requirement set forth in Sections 9.1 and 9.3 of the CAT NMS Plan to create a unique CAT Customer-ID ("CCID") for Customers who do not have a social security number ("SSN"), individual taxpayer identification number ("ITIN") or employer identification number ("EIN") (collectively, "Foreign Customers") until July 31, 2023 in order to conduct a study and implement any related technical changes to the CAT System.
- On September 13, 2021, the Plan Participants submitted to the SEC a <u>request for exemptive relief</u> from the requirement in Section 6.4(d)(ii)(C) of the Plan and the Phased Reporting Exemption for Industry Members to report Customer addresses at the Customer level to the CAT beginning in Phase 2e. As a condition to this relief, the Participants would require Industry Members to report account mailing address to the CAT and to optionally report Customer address, if it is available and different than the account mailing address.

New FAQs

- ▶ Three Transaction <u>FAQs</u> published since the last Monthly CAT Implementation Update (September 9, 2021).
 - B75 clarifies the Phase 2d requirement to capture and report the date and time an Industry Member received a request from a customer or another Industry Member to modify or cancel an order.
 - K19 clarifies that starting in Phase 2d, Industry Members must use the 'PBG' handlingInstructions value on options orders events
 when the limit price is based on option Greeks or another formula based on market conditions.
 - K20 clarifies the reporting requirements for the pairedOrderID field.
- Four CAIS FAQs published since the last Monthly CAT Implementation Update (September 9, 2021).
 - Q51 clarifies how Industry Members should populate the roleStartDate field if it did not record the date on which the Customer entered the specified role.
 - Q52 addresses how Industry Members should populate the "end date" fields when an event triggers the closure of an account.
 - Q53 was added to clarify how account transfers between broker-dealers should be reflected in CAIS.
 - Q54 clarifies how to populate the 'ADDRESS1' value if the FDID is based on a relationship that represents multiple customers with different addresses and the addresses are maintained at the customer level.

Updated FAQs

- Twenty-one Updated Transaction <u>FAQs</u> published since the last Monthly CAT Implementation Update (September 9, 2021).
 - FAQ B53 was updated to include examples of account transfers that are not reportable to CAT.
 - FAQ D23 was updated to clarify the accountHolderType requirements when the FDID represents a Relationship ID.
 - FAQs K5 and K14 were updated to clarify that Buy/Writes must be reported as multi-leg orders starting in Phase 2d.
 - FAQ K2 was updated to clarify the definition of "Paired Option Order".
 - FAQ U22 was updated to state that certain allocations to average price accounts of an Introducing Broker required in Phase 2c will become optional starting in Phase 2d.
