- Enforce requirements to populate *clearingFirm* on MOOT event

#### Schema changes and related validations

- Add new event MLOE
- Enforce requirements to populate *cancelQty, multiLegInd* on applicable events
- Change data type for *handlingInstructions* value CASH from Text to Price to capture actual monetary value instruction

### 'DLVT' handlingInstructions Value

DLVT – OTC Link ATS Message deliver to Instruction

- Current Data Type is Text and supports reporting of multiple IMIDs, but it does not support storage of multiple IMIDs
- Effective 2/7/22 in Industry Test and 3/21/22 in Production, Industry Members must report this handlingInstructions value as an array to ensure CAT stores all IMIDs. Submissions in text format will be rejected at Ingestion. Example of expected submissions:

#### **Compliance Updates**

### 2022 Annual Clock Synchronization Certification

- Industry Members must complete an annual certification for Business Clock Synchronization by March 15th of each year.
- Industry Members are not required to submit such certifications to the exchanges or FINRA. Instead, originals of such certifications must be maintained by Industry Members as part of their books and records and be available to regulators upon request. Industry Members who are members of multiple Participants need only make a single clock synchronization certification.

- The <u>Requirements Announcement</u> is also posted to the <u>Clock Synchronization</u> page of the CAT <u>website</u>.
