# **Error Feedback and Timing**

- Schedule for FDID validation of CAT Transaction records in various environments
  - > Test currently available and uses data from Full CAIS Production environment
  - Prod-Mirror 12/5/2022 changed from 11/7/2022
  - Production 12/5/2022 changed from 11/7/2022
- > CAT will perform FDID validations between 8am and noon on T+1
- > Related feedback will be available by T+1 noon with other linkage feedback
- New Errors Summary feedback file will be provided with error counts grouped by FDID and Message Type
- FDID Errors will be included in the daily statistics starting 12/5/2022 and the Compliance Report Cards starting with the January 2023 Report Card

# **Transaction Events with FDIDs**

The following order and allocation events currently contain the firmDesignatedID (as well as the newOrderFDID, as applicable) and are inscope to receive FDID Validation Errors

# **Transaction Data Validation Approach**

CAT will validate that the *firmDesignatedID* and *newOrderFDID* values provided on all transactions are present and active in Full CAIS Production

Events not passing the validation will be considered errors not rejections

 Every event having an invalid FDID will generate an error and will be included in compliance metrics on the processing date

 Events with FDID errors will be accepted by CAT and will fully participate in the linkage process

# **FDID Reference Data**

The CAIS system will provide all available FDIDs in Full CAIS Production environment as of T+1 at 8am

- FINRA CAT will be analyzing the final FDID list available after T+1 at 5pm to determine if there are FDIDs that were not present in the T+1 at 8am file
- If FDIDs are found in the T+1 at 5pm file that were not present in the file used for the transaction validation, FINRA CAT will communicate this to the impacted firms
- FINRA CAT has multiple files with snapshots of CAIS Production data taken at different time intervals that can be used if there are processing delays with T+1 at 8am file
- Use of an earlier file may result in false errors, and this will be communicated to IMs

> If a false alert occurs, it will automatically reconcile the next day

# **FDID Error Corrections**

> FDID errors where the FDID is missing in CAIS

- A submission accepted into CAIS will reconcile the error
- Corrections for CAIS data having errors are due by T+3 at 5pm
- Related errors in transaction data will be reconciled
- Reconciliation process runs for 90 days

FDID errors where the FDID has been correctly reported to CAIS, but incorrectly reported on the transaction side

- The FDID must be corrected on the transaction side and resubmitted
- Corrections for CAT events having FDID errors are due by T+3 at 8AM

## **FDID Validation Error Codes**

The following 10 new error codes will be delivered in the existing linkage error files and in the format of the original submissions



# **Reporter Portal Statistics**

- Error Code Counts screen will include the records that are in error with the corresponding error codes
- > **Reporting Summary** screen will include a separate section that includes:
  - Accepted FDID Errors Count
  - Repaired FDID Errors Count
  - > Initial FDID Error Rate (Accepted FDID Error Count/Total Accepted Record Count)
  - Adjusted FDID Error Rate (Accepted FDID Error Count Repaired FDID Error Count / Total Accepted Record Count)
- Report Cards screen will include FDID Errors and Repairs (counts & percentages) by Product and Overall
- > Overall compliance error rate on reporting summary and report cards screen will include the outstanding FDID errors. If the record has other errors, it is only counted once


