# Industry Member Release Rollout

## 2023 Release 1- Customer Address Validation Industry Test – 7/10/2023 Production – 8/7/2023

- Enhance the 22514 Error Code to require an address on every Customer Record
- Enhance Manual Submission screen to require an address on every Customer Record
- Enhance Manual Submission enabling users to copy addresses entered on the FDID Record to a Customer Record

\*Per FAQ Q67, effective July 12, 2023, each Customer must be reported to CAIS with at least one address.

## 2023 Release 2 Industry Test – 9/25/2023 Production – 10/23/2023

- New value of 'INACTIVE' for *fdidEndReason*, *roleEndReason* and *ltidEndReason*
- *customerRecordID* returned as a Data Type of Array in feedback files
- Address [Known Issues](#) impacting Reporter Portal and Data Validation
- Error Code 22914 added to the list of acceptable codes for use in the *correctionList*.

\*A network block will be in place the weekend of 9/24/2023 for both Transaction and CAIS Test environments.

# 2023 SIFMA DR Test

---

- ▶ FINRA CAT, along with selected CAT Reporters will participate in the 2023 SIFMA DR Test in similar fashion to the 2022 SIFMA DR Test.
- ▶ Selected CAT Reporters have been notified and have received test scripts.
- ▶ The 2023 SIFMA DR Test will:
  - Occur on Saturday, October 14, 2023 (8 am to 2 pm ET)
  - Require both Full CAIS and Transaction submissions
  - Only validate ingestion and will provide ingestion feedback (note: no linkage feedback process will be executed).
- ▶ FINRA CAT plans to use its Enhanced Disaster Recovery environment (EDR) in the AWS East-2 Region.
- ▶ FINRA CAT will utilize the Production Mirror Environment in that region. (Please utilize the [Connectivity Supplements for Industry Members](#) for additional network connectivity configurations.)
- ▶ Submitters should test their network connectivity to this new region between September 23, 2023 and October 13, 2023 (prior to the October 14, 2023 test date).
- ▶ FINRA CAT will host a SIFMA DR Test meeting with selected Submitters on Tuesday, October 3, 2023 (meeting invitation will be distributed this month).

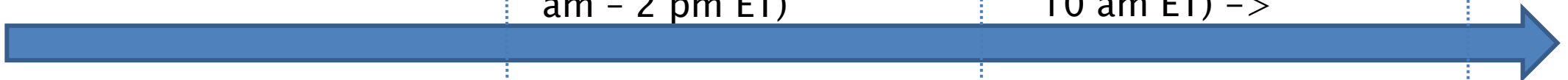
