- Industry Members have requested to have unique statistics available to them on a go forward basis.
- To address the Industry Member ask, overall unique rejection statistics will be available on the CAIS Reporter Portal daily beginning August 19, 2024. Unique rejection statistics will also be added to the Report Card at a later date.
