Add New Boolean Flag

- Add *BFMMFlag* as a conditional Boolean field (true/false) on MENO, MEOM, MEOT and MEOTS events to identify Short Sale orders originated or modified when relying on the bona fide Market Making exception under Rule 203(b)(2)(iii) of Regulation SHO.

The compliance date for BFMMFlag reporting is July 1, 2025.

Removal of *handlingInstructions* Values

- Remove 'MAO', 'MAC', 'AOB' and 'MOB' *handlingInstructions* values.

- ▶ The [Order and Quote Routing Field Mapping between CAT and Exchanges](#) document was updated on August 22, 2024 to reflect updates for MIAX Sapphire.
- ▶ [CAT Alert – 2020-03: Options Market Quote Sent Time](#) was updated on August 28, 2024 to update hyperlinks to regulatory circulars for MIAX Emerald, MIAX Options Exchange, MIAX Pearl and MIAX Sapphire.

 - This field will first appear in the CAT Billing Trade Details for the September 2024 Invoice, issued on October 25, 2024.
- ▶ An updated CAT Billing Trade Details Schema will also be published on September 24, 2024.
- ▶ There have been no updates to the CAT Billing Scenarios document.

- ▶ FINRA CAT, along with selected CAT Reporters will participate in the 2024 SIFMA DR Test in similar fashion to the 2023 SIFMA DR Test.
- ▶ Selected CAT Reporters have been notified and have received test scripts.
- ▶ The 2024 SIFMA DR Test will:
 - Occur on Saturday, October 5, 2024 (8 am to 2 pm ET)
 - Require both Full CAIS and Transaction submissions
 - Only validate ingestion and will provide ingestion feedback (note: no linkage feedback process will be executed).
- ▶ FINRA CAT plans to use its Enhanced Disaster Recovery environment (EDR) in the AWS East-2 Region.
- ▶ FINRA CAT will utilize the Production Mirror Environment in that region. (Please utilize the [Connectivity Supplement for Industry Members](#) for additional network connectivity configurations.)
- ▶ Submitters should test their network connectivity to this new region between now and October 4, 2024 (prior to the October 5, 2024 test date).
- ▶ FINRA CAT will host a SIFMA DR Test meeting with selected Submitters on October 1, 2024.

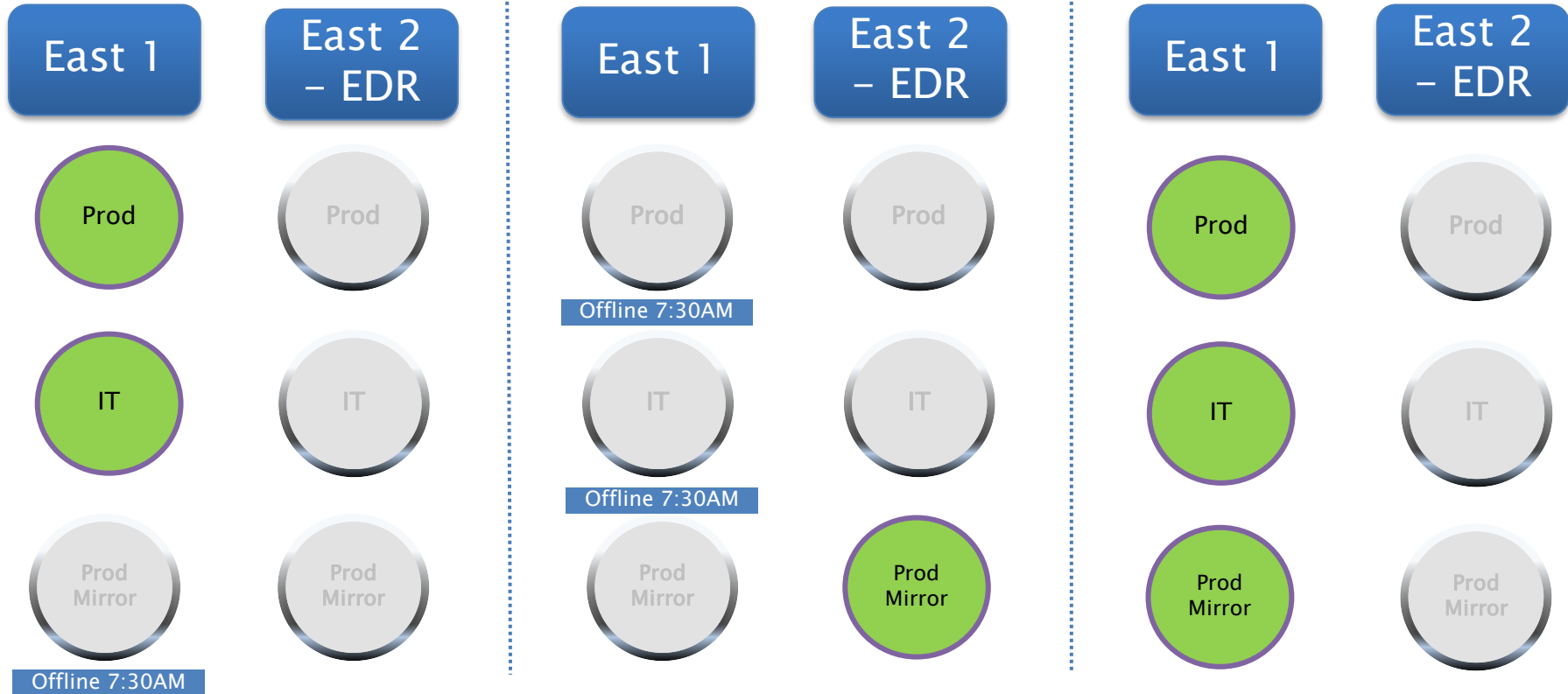
